INTRODUCTION

The schools programme involves visits to Grade 9 learners during the first three quarters of the year. The visits commence in February of each year which is outside of this reporting period. Funding was approved and received very late 2019, and unfortunately resulted in the schools program not able to kick off in the first quarter of 2020. However planning was in place to continue and adapt the schools visit in the second and third quarter.

It is essential that we encourage children to be aware of the value of agriculture as a source of food and fibre, an major role player in the economy, as an employer, and as a career choice. More than half the population in Africa is under 20 years of age. We will identify suitable persons who can take the presentations to the Grade 9s of the various schools. They will be visited each quarter for the first three quarters of 2019. Should other donors be identified, the number of schools will be increased.

- 3. Visit the schools once a quarter for each of the first three quarters and do a presentation followed by a discussion to the Grade 9 learners. (Food, Fibre and Life; Agriculture Dig in What is it all about; The Economy what's in it for me?; Our daily bread the story of Wheat; The Soya Bean wonder food, Careers with Plants and Careers with Animals).

CURRENT PROJECT CONSTRAINTS

- 1. Funding approval received late 2019 resulted in first quarter needed to extend into second and third quarter of the school year.
- 2. As indicated to the administrator of the trust the CONVID 19 virus and regulations is currently of great concern. Schools are closed and some of the regulations hinder the progress of the project.
- 3. With the Schools opening the Schools were not willing to participate in the project due to limitation of time and curriculum constraints.
- 4. The Trust indicated that these fund must be utilised within the new year
